I have read your recent public comments regarding Question 3 and noted your ongoing dialogue with the measure's proponents. I felt it was important to remind you of the position of the Nevada Resort Association (NRA) and its members on this issue.

As you are well aware, the NRA has always had a clear policy to support a broad revenue source for education funding, without unduly burdening one industry, and our members have consistently participated in discussions to that end. We have also consistently expressed our belief that our Governor and Legislators were elected to address these issues at the legislature. We look forward to the proposals from the Governor and Legislative Leaders in the upcoming legislative session to address not only education, but other important state services such as mental health.

Let me be clear — if you continue your discussions, and perhaps negotiations, you do not represent the NRA and its members, nor do we empower you to claim that you represent the entire business community's position on this issue.
