Dear Mr. Egan, Ms. Cordova, and Mr. Witkoski:

On behalf of Las Vegas Sands Corp. and its affiliates, including the Venetian Casino Resort, LLC (collectively "Venetian") we file this letter pursuant to NAC 704B.320, which provides that "[n]ot later than 30 calendar days before the date on which an eligible customer files an application pursuant to NRS 704B.310, the eligible customer shall submit a letter of intent to file the application." NAC 704B.320(1). Venetian intends to file an application pursuant to NRS 704B.310 no sooner than thirty 30 calendar days following the date of this letter. Venetian is an eligible customer pursuant NRS 704B.080 which defines "eligible customer" as a nongovernmental, commercial, end-use customer that has an average annual load of more than 1 megawatt in the Nevada Power Company d/b/a NV Energy's (the "NPC") service territory. Venetian consumes over 1 megawatt of electricity to operate its integrated resort campus in Southern Nevada which includes the Venetian Las Vegas, the Palazzo Las Vegas, and the Sands Expo and Convention Center. This contiguous property is serviced by four NV Energy accounts and is located at 3355 S. Las Vegas Boulevard, Las Vegas, Nevada 89109 and 201 Sands Avenue Unit A, Las Vegas, Nevada 89169.

Venetian will apply to receive energy from a qualified energy provider that will provide energy, capacity or ancillary services from one or more identifiable new electric resources, including the location of the new electric resource or identification of the market for the new electric resource. Venetian will provide this information as soon as it has selected an energy provider.

Venetian will submit a Network Integration Transmission Service (a.k.a. "NITS") application commensurate with this filing. Venetian intends to purchase energy from the provider at the following points of delivery (the "POD"):

- **Point of Delivery:** The respondent will transmit all of the power required to the NVE POD at the Mead 230kV or an alternate POD on the NV Energy system and utilize Venetian's Network Transmission rights to deliver all energy and ancillary services to the Venetian Designated Network Load within the NV Energy Balancing Area Authority.
- **Physical Location of Point of Delivery:** NVE POD at the Mead 230kV or an applicable alternate POD on the NV Energy system.

Once a provider is selected, Venetian and the provider will enter into a contract relating to the provision of energy. Venetian will then file its 704B application.
